NHA Golf Tournament Declared a Success

The Second Annual North Houston Association's golf tournament exceeded all expectations.

"Our goal was to net \$13,000 in this year's tournament, and we surpassed our goal by \$4,000," said Marlisa Stanley, executive director. "This nearly doubles the amount of funds raised in 1995."

The 1996 tournament raised more than \$17,000 to benefit the programs and projects of the North Houston Association (NHA).

"All the credit goes to our sponsors and committee members for taking an active part in this year's event," said Stanley.

The winner of the tournament was Turner Construction Company. Second place went to JNS Consulting Engineers, Inc. Tied for third place was LJA Land Development, Engineering & Surveying and Star Enterprise.

Harris County Commissioner Jerry Eversole and Montgomery County Judge Alan Sadler were the tournament's honorary cochairmen and took an active role on the course and in the program.

Economic Development Committee

Reprints of the small North Houston Association Aerial Land Use Maps are complete and available for purchase through the NHA office. The small maps were so popular that the association was sold out of them earlier in the year. The committee will consider updating the map early in 1997.

The economic development committee is currently researching the feasibility of enlisting a labor market study for the north Houston region.

Many member companies have noted that when relocation prospects contact them about moving to Houston, a large hindrance is the city's high wage rates. There is not currently a study that breaks out north Houston's wage rates apart from the city's.

The committee is working with the Greater Houston Partnership and CDS Research, as well as several member companies, to determine the cost versus benefit of such a study.

Environment Committee

Senator Elect and NHA President Jon Lindsay led a discussion on water supply at the October Environment Committee meeting.

At the meeting, he distributed the first draft of legislation proposing the creation of a new water authority. The committee will have a series of subcommittee meetings in October and November to review the details of the legislation.

The committee and the Board of Directors will then give their final comments to Senator Elect Lindsay for consideration.

This is an ideal opportunity for association members to communicate directly with their future Senator about an issue vital to all of north Houston. To receive information on this issue, contact Marlisa Stanley at the NHA office (875-0660).

Transportation Committee

The Transportation Committee's Airport Connectors Subcommittee is currently holding meetings with various agencies to discuss the completion of projects that will improve mobility in the Houston Intercontinental Airport area.

The subcommittee members will be meeting with representatives from the Texas Department of Transportation, the city of Houston, Harris County, Metropolitan Transit Authority, Harris County Toll Road Authority and the city of Humble.

After gathering information from the agencies, the subcommittee will work with the city of Houston's Aviation Department to compile a document that graphically displays the projects.

NHA will use the document to coordinate with the appropriate agencies to move projects forward that will improve mobility in the airport area.
