NHA Members Briefed on Grand Parkway's Future

After nine months of research and work between the North Houston Association (NHA) and several transportation agencies, the association presented a factual document on the current status of the Grand Parkway to its membership.

The document was distributed at NHA's quarterly membership luncheon on July 8. Texas Department of Transportation's (TxDOT) Houston District Engineer, Gary Trietsch, Wesley Freise, executive director, Harris County Toll Road Authority, and Diane Schenke, executive director, Grand Parkway Association, spoke at the event.

A resolution allowing negotions to take place regarding the parkway is currently awaiting approval by TxDOT, according to Schenke.

"Nobody knows how long it will take to reach an agreement. Our goal is within the next six months," said Trietsch.

According to Schenke, the Grand Parkway Association's board of directors has already approved the resolution, as has Harris County's Commissioners Court.

Freise identified three issues that are possible barriers to the parkway's completion: funding, right-of-way acquisition and environmental constraints. He noted that the most difficult issue at this time is funding.

The North Houston Association formed the Grand Parkway Committee following a request from Congressman Brady that the organization revisit the issue and investigate the possibility of the northern segments being completed.

"I would like to thank you for your

hard work and contributions to the completion of the Grand Parkway," said U.S. Representative Kevin Brady in a letter to the Association. "The North Houston Association...continues to be instrumental in moving the parkway from idea to reality."

The purpose of the Grand Parkway Committee is to gain a better understanding of the constraining factors for implementing the Grand Parkway and to assist in educating the public on the need to support expanded infrastructure in north Houston.

Committee cochairmen are Glenn Graham, Espey, Huston & Associates, and David Millikan, HNTB Corporation.

The committee's first step in reaching its goal was to meet with a number of transportation agencies and other appropriate specialists to gather information on the Grand Parkway.

The Association then documented the factual information gleaned from

these meetings to create a publication that includes project history, creation of the Grand Parkway Association, current alignment of the parkway, funding possibilities, environmental constraints, legislation and current status of the northern segments (F, G and H).

Environment Committee

TNRCC's visit to Houston was an informational one (see related article). The Environment Committee will continue to follow this wetlands issue as more develops.

The Texas Water Development Board's Regional Planning Group for Region H has met three times since it was created.

The planning group, chaired by Jim Adams of the San Jacinto Water Authority, is responsible for developing a regional water plan for a 15-county area, including Harris County.

The group's executive committee is made up of the following individuals: Chairman Jim Adams, Vice Chairman

Judge Mark Evans, Secretary Frederick Perrenot, Michael Sullivan (small business representative), and Harold Wallace (water utilities representative).

Ron Neighbors, executive director of the Harris-Galveston Coastal Subsidence District and member of the Region H Planning Group, will speak at the September 10th Environment Committee meeting.

Harris County's draft Regulations for Development Projects are still being revised by the county. The county plans to hire a team of consultants to handle the design items in the document. NHA will have an opportunity to comment on the revised draft document.



Grand Parkway Committee

The Grand Parkway Committee has compiled all information gathered on the project into one comprehensive informational document, which was distributed at the North Houston Association's recent membership luncheon (see cover story).

Transportation Committee

The Airport Connectors document has been updated with new project information and is currently being reprinted.

The Transportation Committee continues its revision of the Association's Mobility Update.

A database is being created to house information on transportation projects in the north Houston region. It will be useful in the periodic revisions of the Mobility Update as well as serve as a resource to NHA members when seeking information on mobility projects in north Houston.



Alliance of North Houston Chambers of Commerce

The Alliance of North Houston Chambers of Commerce (ANHOC) held its first regional planning session in May.

In addition to ANHOC members, invited elected officials, including Harris County Judge Robert Eckels, Montgomery County Judge Alan Sadler and the city of Houston's Chief of Staff Al Haines attended the event.

At the session, it was decided to focus on four major areas of interest in the next year: water supply, transportation, air quality and skilled workforce acquisition/development.

ANHOC is a legislative-oriented alliance made up of representatives from the North Houston Association and six north Houston area chambers of commerce.

TNRCC Speaks on Draft Guidance Document

The North Houston Association hosted a meeting in August to educate

its members on the Texas Natural Resource Conservation Commission's (TNRCC) recently released draft Regulatory Guidance Document for Iimplementation of Texas Water Quality Certification Rules.

"We asked TNRCC to brief our membership on the guidance document so that our committee as well as our individual members will be well informed on the draft's contents. This will allow us to submit

pertinent comments to the TNRCC during the public comment period," said HNTB Corporation's David Millikan, chairman, NHA Environment Committee. "Many NHA members face wetland permitting issues on a regular basis and benefit from learning about the latest

proposed regulatory guidelines first hand."

TNRCC staff member Carol Kim pointed out that, "No new policies are being created. The purpose of the document is to provide guidance on current policies. We are trying to improve coordination with the Army Corps of Engineers."

TNRCC is responsible for conducting 401 certification reviews of U.S.

Army Corps of Engineers Section 404 permit applications for the discharge of dredge or fill material into waters of the U.S., including wetlands. This regulatory document, Implementation of Texas Water Quality Certification Rules, is designed to provide assistance, information, and clarity to applicants seeking certification of such permits.

Draft copies of the guidance document are available

at the NHA office. Deadline for comment to TNRCC is September 3. NHA will meet jointly with the West Houston Association and the Greater Houston Partnership on August 12 to compile a joint set of comments which will be forwarded to TNRCC.

NHA Adds Three New Members

Town Center Improvement District

(TCID) was created by the Texas Legislature in 1993. TCID is a unit of government chartered to provide services to benefit the public within a 1.2 square mile area of The Woodlands Town Center. Located north of Houston in Montgomery County, Town Center is the business, retail and entertainment "downtown" of the highly-acclaimed master planned community, The Woodlands. TCID's initial focus on public safety has led to a significant police presence in Town Center.

The District has expanded its program efforts to include marketing and promoting the image of Town Center, hosting region-wide events, visual improvements, and economic development.

TCID's activities are funded solely by a one-cent sales tax in The Woodlands Town Center. The District utilizes these funds to provide public services and enhancements to maintain Town Center as a safe and attractive urban center.

The third new member is Union Pacific Railroad Company (UP), the largest railroad in North America. UP is an operating subsidiary of Union Pacific Corporation (NYSE:UNP).

It operates in the western twothirds of the United States and serves 23 states. The railroad is the primary rail connection between the U.S. and Mexico.

UP has one of the most diversified commodity mixes in the industry, including chemicals, coal, food and food products, forest products, grain products, intermodal, metals and minerals, and automobiles and parts. UP's largest customer is APL Limited, a steamship company that operates in the Pacific.

NHA-TMO Receives Award

The North Houston Association's Transportation Management Organization (TMO) recently received an award from the Clean Air Action Program and the Clean Air Coalition in recognition of NHA's actions taken to reduce the impact of ground-level ozone and improve the area's air quality.

"The North Houston Association has assisted in getting the word out about clean air in a number of ways," said Brian Wolfe, senior TDM planner, Houston-Galveston Area Council.

"NHA has hosted a number of transportation booths to educate the public on their commuting options as well as meeting with companies, such as Chelsea Catering (a division of Continental Airlines) to assist their employees in finding alternative modes of transportation."

The Clean Air Action Program is run by the Houston-Galveston Area Council. The Clean Air Action Program and the Clean Air Coalition are voluntary public/private initiatives striving to educate the public about air quality issues and resulting health effects facing the region. Members include governments, businesses, environmental and health organizations, transportation authorities and public interest groups.

50% Off Metro in August

August is Clean Air Month, and Metro wants to do its part in reducing high ozone concentrations caused from several emission sources like autos and industry.

Through support of the Clean Air Coalition and its Clean Air Action Program, Metro is offering half-price fares during August.

All cash fares will be half price, and stored value cards will be discounted automatically at the fare box. All daily, weekly and monthly passes will be at 50 percent off the normal purchase price. This discount will be in addition to any

already discounted fares for students, seniors, etc. Also, the Texas Special buses that run downtown will be free in August.

In addition to leaving your car at home, there are a number of other things you can do to help in the fight for clean air: combine errands for fewer trips, avoid idling in drive-through lanes, keep your vehicle properly tuned to keep exhaust levels low, postpone refueling until late afternoon, don't top off gas tank when refueling, make certain your gas cap is tightly sealed, and use electric instead of gas powered tools.
